This refers to your letter of 15 May 2024, (signing as Delhi State Coordinator) addressed to the Sahaj Yoga Central Committee of India (SYCCI) informing the SYCCI that the LET Delhi has unilaterally decided to disassociate itself from the Sahaja Yoga Central Committee of India. SYCCI is shocked and dismayed at this patently arbitrary and amoral announcement.

Most importantly, all of you must realise that this arbitrary and amoral decision by you, claiming to represent the Delhi collective, is in complete violation of Shree Mataji's clear and explicit instructions to establish the India Central Committee. With such overt and direct refutation of Shree Mataji's instructions, do you still consider yourself to be fit to be called Her follower, let alone Her children for whose spiritual birth and evolution, She worked so selflessly and tirelessly all Her Sakaar life.

We would like you to explain to the Delhi collective what was the compulsion to disobey Shree Mataji's explicit instructions (Adesh)?

Your arbitrary decision is also in complete violation of all expected code of conduct of running a Trust, let alone a sacred Trust established by Shree Mataji.

Did you for example, consult the Delhi/NCR collective at any point, before taking this sacrilegious decision?

Was a formal meeting of the LET Delhi called to discuss this decision? Was a notice given for the meeting? Who all were present in such a meeting?

Was the resolution for disassociating LET Delhi from the SYCCI approved by a majority of the Trustees present at such a meeting? Clearly neither was such a meeting ever called nor a resolution passed.

Having arbitrarily written to the SYCCI informing it of the decision, was the collective duly informed even post facto? We believe not. Otherwise please let us know the date on which this was done.

We would like you to share this message with all the Trustees of LET Delhi and the Delhi collective. Let the collective decide if they would entrust the running of LET Delhi to persons who have brought such SHAME on Sahaja Yoga and Nirmal Dham.
